01. The Director General of the Sri Lanka Sustainable Energy Authority (SLSEA) invites you to submit a quotation/bid for the supply of goods/services as specified in the attached Terms of Reference.
02. You should submit the quotations/bid in the format in the Annexure IV (Quotation/bid form) filling all the blank space with the information/data requested therein **together with a detailed quotation.**
03. You are also advised not to quote different options for the same item but submit offer for the competitive among the options available. All the items mentioned in the TOR/Specification (Bidding Document) to be priced separately and the total price/cost exclusive of trade discounts to be quoted in Sri Lanka Rupees in the attached payment schedule.

The price/rates quoted by the bidder shall be fixed and not subject to variation during the contract period. The documentary evidence in the form of technical specifications, drawings, manufacture certificates or other form of data shall be furnished as part of the quotation to prove confirmity of the goods/services offered to the technical specification/ standards requested.

Submission of incorrect information as evidence shall result in disqualifying for further evaluation of bid and discontinuation of relationship as a reliable source of supply.

04. The price/rates quoted shall remain valid for a period of ninety days (90 days) after the date of submission of quotation.
05. The quotation shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the bidder.
