A Quotation submitted with an adjustable price shall be treated as non responsive and may be rejected. 6. Currency 6.1 The vendors shall quote only in Sri Lanka Rupees. 7. Documents to 7.1 The vendor shall furnish as part of its quotation the documentary Establish the evidence that the Goods conform to the technical specifications and standards specified in Section IV, "Technical Specifications & Conformity of the Goods Compliance with Specifications". 7.2 The documentary evidence may be in the form of literature, drawings or data, and shall consist of a detailed item by item description of the essential technical and performance characteristics of the Goods, demonstrating substantial responsiveness of the Goods to the technical specifications, and if applicable, a statement of deviations and exceptions to the provisions of the Technical Specifications given. 7.3 If stated in the Data Sheet the vendor shall submit a certificate from the manufacturer to demonstrate that it has been duly authorized by the manufacturer or producer of the Goods to supply these Goods in Sri Lanka.

VI. Contract Agreement

This agreement is made on and entered into at Colombo in the Democratic Socialist Republic of Sri Lanka on this ... day of September, Two Thousand Twenty-Five (2025) between Sri Lanka Sustainable Energy Authority, a body corporate established under the Sri Lanka Sustainable Energy Authority Act No. 35 of 2007 and having its principal place of business at No.80, Sir Ernest De Silva Mawatha, Colombo 07 (hereinafter called "the Purchaser"), and, a Company duly incorporated under the laws of Companies Act No. 07 of 2007 bearing Registration No.and having its principal place of business at (hereinafter called "the Supplier").

WHEREAS the Purchaser invited bids for purchasing power analyzer and has accepted a Bid by the Supplier for the supply and delivery of those Goods and Services in the sum of LKR without VAT hereinafter called ("the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall constitute the Contract between the Purchaser and the Supplier, and each shall be read and construed as an integral part of the Contract:
 - (a) This Contract Agreement
 - (b) Technical Specifications and schedule of requirements
 - (c) The Supplier's Bid and original Price Schedules
 - (d) The Purchaser's Notification of Award
- 3. This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

- 4. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the Goods and Services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 5. The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Goods and Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
